Welcome to the **2020 Marsh Fest BBQ Cookoff!**

We are excited about this year's contest. Below are few things you need to know this year.

- **NO OUTSIDE ALCOHOL!** You will have the opportunity to purchase beer from the Knights of Columbus at a discounted price. *You will be asked to sign a TABC letter stating you know there will be no outside alcohol brought into park.* If found you will be asked to leave the park and contest immediately, and no refund will be given.
- **NO ATVs or GOLF CARTS!** There will be absolutely no ATVs or Golf carts allowed in the park excepts those that are official Marsh Fest vehicles.
- **ONE VEHICLE PER TEAM ALLOWED IN PARK.** Each team is allowed one vehicle inside park. Sticker is required.
- **MUST LEAVE PARK SUNDAY MARCH 8<sup>TH</sup> BY 8:00 AM!** Due to other events taking place at the park on Sunday morning, you are required to leave the park no later than 8:00 AM....**NO EXCEPTIONS!**

Check in will start at **Noon** on **Friday March 6<sup>th</sup>**. You will enter park from Saint Martin street (same as last year). You will receive your packet with parking pass and bracelets at check in. Checking in will be first come, first placed, *no assigned spaces*.

Dear Marsh Fest Participant,

In an effort to keep the Marsh Fest safe and a family event, your parking permit and/or BBQ contest entry will not be issued until a signed copy of this agreement is received in our office. Because the Knights of Columbus #3452 holds the Beer & Wine permit for the park during the dates of the festival, it is prohibited for any outside alcoholic beverages to be brought inside the festival fencing.

**PARKING PASS HOLDER**

If the parking pass holder is caught by TABC, Chambers County Sheriff's Department, Festival Security or Festival Directors/staff inside the permanent fencing with an alcoholic beverage, not sold by the Marsh Fest or one of its vendors, in their possession or vehicle they will be asked to move their vehicle into the free lots located south of the park and their parking permit will be immediately revoked.

**BBQ CONTEST PARTICIPANT**

If the BBQ participant is caught by TABC, Chambers County Sheriff's Department, Festival Security or Festival Directors/staff inside the permanent fencing with an alcoholic beverage, not sold by the Marsh Fest or one of its vendors, they will be asked to leave the contest and will not be allowed to compete in the BBQ contest.

By signing this agreement, you pledge to adhere to the rules and regulations of the Marsh Fest. Thank you for your dedication to a safe and enjoyable festival.
