Waller County Fair Rules & Regulations

September 11 – 12, 2020

1. This is a **IBCA** Sanctioned Bar-B-Que cook-off. All IBCA rules will apply. <http://ibcabbq.org/wp-content/uploads/IBCA-Rules-Sept-2019-Final.pdf>
You do not have to be a member of IBCA to cook this event.
2. Contestants may begin checking in Thursday September 10, 2020 @ 5pm. Deadline for entry is 10:00pm on Sept. 11, 2020.
3. Teams will consist of one (1) Chief Cook & four (4) team members. Each team must cook on their own pit. Example-2 teams 2 pits 3 teams 3 pits etc... one team can use multiple pits for different categories if they choose.
4. Chief Cook will be responsible for the conduct of his/her team & guests. The excessive use of alcoholic beverages shall be grounds for disqualification. **Under no circumstances are alcoholic beverages to be Sold to the General Public, or given to a MINOR.**
5. It is the responsibility of the Bar-B-Que team to see that the contest area is kept clean, and the area is clean following the contest. (PLEASE) There will be a dumpster provided to dispose of the trash. If you leave your area trashed you will not be invited back.
6. **QUITE TIME IS 12 MIDNIGHTPLEASE!!**
7. If you have a DJ or a Band, respect your neighbors. This is not a battle of the speakers. If you have large amps or speakers keep them turned in toward your spot.
8. Spaces will be 40x30 and 40x20. Pop-ups, Trailers, and Motor homes are allowed. Vehicles and other Equipment may not exceed the boundary of the contestant's assigned space.
9. Cooks Meeting is at 5pm on Friday September 11, 2020. Containers will be given out between 3pm-5pm.
